DECLARATION OF MAINTENANCE COVENANTS AND AND AND CONTROL CONT

RESTRICTIONS ON THE COMMONS FOR

THE MEADOWS

WHEREAS, TAYLOR WOODROW HOMES LIMITED (FLORIDA DIVISION), a corporation under the laws of the United Kingdom, authorized to do business in the State of Florida, hereinafter referred to as "Developer," has heretofore filed a document entitled "Declaration of Maintenance Covenants and Restrictions on The Commons for The Meadows," together with Exhibits thereto, in the Public Records of Sarasota County in Official Records Book 1113, pages 715-759, inclusive; and

WHEREAS, said Declaration was amended by instruments recorded in Official Records Book 1137, page 1968, Official Records Book 1326, page 882, and Official Records Book 1428, page 0552, of the Public Records of Sarasota County, Florida; and

WHEREAS, said Declaration reserves unto Developer the right to amend said Declaration, provided all such amendments conform to the general purposes and standards set forth in said Declaration; and

WHEREAS, said Declaration further reserves unto The Meadowood Management Company, Inc., a Florida corporation not for profit, various rights and responsibilities with respect to the promotion of the health, safety, and social welfare of residents of The Meadows, including the right to promulgate and enforce restrictions applicable to lands within The Meadows; and

WHEREAS, various restrictions applicable to individual condominiums and subdivisions within The Meadows have been recorded, which restrictions, among other things, limit certain uses of and activities on the property within said condominiums and subdivisions; and

WHEREAS, in order to provide more uniform enforcement of such restrictions, it is appropriate to amend said Declaration to provide The Meadowood Management Company, Inc., with such power of enforcement;

NOW, THEREFORE, pursuant to the foregoing authority, and with the joinder and consent of The Meadowood Management Company, Inc., Developer does hereby modify and amend Paragraph 20 of said Declaration to read as follows:

"20. ENFORCEMENT OF RESTRICTIONS. During the course of development of The Meadows, Developer may, from time to time, delegate the responsibility for construction, architectural, and other approvals of residential improvements to be made in The Meadows to the respective Neighborhood or Condominium Associations of the various sections or subdivisions of The Meadows, including the right to approve any additions, changes, or alterations therein, which right of approval shall be set forth in the property restrictions applicable to each section or neighborhood area. Developer, furthermore, may, from time to time, delegate to such Neighborhood or Condominium Associations the responsibility for enforcing activity and use restrictions applicable to their respective neighborhood or condominium area. In the event any Neighborhood or Condominium Association should fail or refuse to exercise properly the foregoing responsibilities, as may be determined by Meadowood, in its sole discretion, then and in such event the board of directors of Meadowood shall have such right of approval or disapproval, and may exercise such right of enforcement, as to all matters or questions for which such Neighborhood or Condominium Association fails or declines to exercise properly its responsibility. In the further event that there is no Neighborhood or Condominium Association in existence to whom such responsibilities may be assigned by Developer, then Developer may assign such responsibilities to Meadowood."
